Sub: - <u>Issue of Presidential Order to (Late) Sri. G. Anthony Selvaraj, (HR Number20012139) Telecom Technician,</u>
<u>Mangalore, Karnataka – reg.</u>

BSNLEU has taken up the agenda of issuance of Presidential Order to left out TSM/RMs and TTs of various Circles. This particular agenda has been discussed continuously at various levels of official meetings, including National Council meetings. Due to this continuous pressure from our Union, the Corporate Office has endorsed the DoT letter on clarifications/instructions regarding forwarding of cases for approval of P.Os., vide letter number BSNLCO-A/13(16)/04/2020-estab Dated 21.08.2023, wherein the Corporate Office has instructed the CGMs to forward all the pending cases seeking issue of P.O. in respect of left out casual laborers/TSMs.

However, it is noticed by our union, that despite this clear instructions from Corporate Office, the CGMs have not sent the particulars of the left out cases for issue of PO, available in their Circles, instead were corresponding with the CGM of the other circles, from where the TSMs/RMs came on R-8 transfer.

In substantiating our argument, we bring it to your notice the case of, late Sri. G. Anthony Selvaraj, who has been conferred with Temporary status and regularization w e f 01.10.1989, vide TDM Itanagar (Arunachal Pradesh) letter number E-5/95-96/ Dated 10.04.1995. He has become RM since 01.10.2000. Promoted as Telecom Mechanic w.e.f. 01.12.2001, on completion of TM training at CTTC NE Circle, Shillong, followed by his confirmation in the TM cadre w e f 01.12.2003. Later, he was transferred to Mangalore, (Karnataka) under R-8 from Arunachal Pradesh (NE.II) on 20.07.2006. The SDE (Admin) O/o. GM Mtce, ETR Shillong vide his letter number 42-25/SB dated 28.09.2006 has transferred the Service Book, Leave accounts and Personal File of Sri.G.Anthony Selvaraj, to SDE(ADMIN) o/O GM Telecom District, Mangalore, Karnataka.

Though the Service book and PF of Sri. Anthony Selvaraj (HR Number 20012139) was available in Karnataka Circle, he could not get his PO, despite several appeals. Further, the CGM Karnataka Circle has also not brought it to the notice of Corporate Office, as per the instructions of Corporate Office, as cited above. Sri. G. Anthony Selvaraj was made to correspond with NE II Circle, as he has been conferred with TSM and regulisation status at Itanagar, as advised by local authorities at Mangalore, Karnataka. The latest position is, Sri.G Anthony Selvaraj, Telecom Technician, (HR Number 20012139) demised on 04.04.2024, and as on date his Pensionary benefits are to be settled to the family of the deceased employee. He is deprived by two level Non-Executive promotion benefit also, only because of non-issuance of PO.

We request you Sir, to intervene in this issue on priority, and to cause with the issuance of PO as per DoT letter forwarded by Corporate Office as cited above.
