Subject: Regarding settlement of TA Bill.

I am directed to refer to the Circle's letter No. CGMT/UP(East)/Gen. Corr./K.L.Bharti/dated 29.08.2019 seeking clarification as to whether the retired employee is eligible for getting retirement TA for settling in his hometown when he is still getting the BSNLMRS reimbursement from the office from which he retired.

The matter has been examined in consultation with Estt Branch (PAT Section) of Corporate Office and it is clarified that the retired employees have, for their convenience, been given the option vide this office letter dated 16.5.2011 (copy enclosed) to avail medical facility from the place of their settlement. Since the facility is optional, it does not prevent any retired employee from settling at his hometown and claiming medical reimbursement from the office from which he retired. In such a case, the employee would be entitled for the TA for settling at his hometown after retirement.



Office Order

Sub: Availing of medical facility by the retired employees from the offices located in place of settlement of the retired employees.

Ref: Order No. BSNL/Admn.I/1 (Pt) dated 23rd August 2006 stipulating procedure for reimbursement of medical claims for retired employees.

It has been observed that employees continue to avail medical facility from the place of retirement even after shifting their place of settlement. For the convenience of the employees and the administration, the competent authority has approved that the employees may change their claim office to their place of settlement. Provisions are made in Clause 1.4 of the orders referred above for change of place of settlement. Therefore retired employees who change the place of settlement may change their claim office to their place of current settlement for early settlement of their claims and also for availing credit facility from the local empanelled hospital during hospitalizations.
